This Privacy Notice provides further detail on how your information may be shared through the This Way 4 English programme. These details explain how we use and share any information we collect during your engagement with the programme.

This Way 4 English challenges social and economic exclusion amongst particular groups in Kirklees, by creating opportunities for access to learning, qualifications, volunteering and employment. The programme is principally aimed at people who find it difficult to engage with, and may feel isolated, from ESOL activity.

This Way 4 English programme is currently funded by The Ministry of Housing, Communities and Local Government and overall delivery is managed by Third Sector Leaders (TSL), a charitable incorporated body providing a voice for charities and not for profit groups who are working to support Kirklees people, families and communities on behalf of Kirklees Council. This organisation is the Data Controller and is responsible for the collection and secure storage of your information.

In addition, we will share your information with: **Kirklees Council**

With your agreement we will be working with and therefore sharing your data with Kirklees Council and the Ministry of Housing, Communities and Local Government. We may also share your details with other organisations who may be able to offer you additional support. This will be dependent upon your individual requirements and will only be done with your express permission.

There is a data sharing agreement in place between Kirklees Council and TSL, ensuring all data is securely transferred, handled, stored and destroyed.

How we will further use your information: If you are participating on the programme your information will also be used for statistical analysis to ensure the success of current and future programme delivery. The information will be used in conjunction with details of other learners on the programme to produce aggregated numerical data and you will not be personally identifiable.

How will your information be stored: Paper based information is stored in a locked filing cabinet in a secure office whilst data held digitally is saved on a password protected file.

How long will we keep your information: We will keep your information for 1 year after the programme has finished and then paper information will be shredded and digital information deleted.
